The Participant is obligated to conduct tests and submit them to the PT Organizer without coordinating with other Participants, whose participation in the program is known to them from other sources. In the event of collusion being identified, Participants will be disqualified from the respective round.

In the case of too few registrations, the PT Organizer may extend the registration period (which may affect the deadlines specified in the Program Schedule for a given round) or cancel proficiency testing for a specific property. Participants will be promptly informed of any changes.

Failure to submit proficiency test results by the Participant, as well as disqualification due to identified collusion, does not exempt the Participant from the obligation to pay according to the scope of the registered participation.

The participant has the right to withdraw from participating in proficiency testing at no cost, which requires submitting a written resignation to the email address: badania.bieglosci@barg.pl within 10 days before the planned sample delivery date.

The transportation of samples is at the participant's expense, through a freight forwarding company and according to its price list.
