As part of this Proficiency Testing Program, the Participant:

- takes samples of the fresh concrete;
- performs fresh concrete testing;
- performs concrete samples;
- submits the concrete samples to the PT Organizer for setting in accordance with the requirements of the standard;
- collects the concrete samples from the PT Organizer and transports them to its own location, where the samples will be unmolded, cared and then tested.

The registration form should be sent as a scanned copy to the email address: badania.bieglosci@barg.pl by March 15, 2024. Submitting the registration form is equivalent to accepting the Proficiency Testing Program and financial conditions, as well as committing to confidentiality regarding obtained test results in relation to other Participants and securing documentation related to proficiency testing from unauthorized access. The Participant is obligated to sampling / conduct tests and submit them to the PT Organizer without coordinating with other Participants, whose participation in the program is known to them from other sources. In the event of collusion being identified, Participants will be disqualified from the respective round.

The sampling date, due to forecasted weather conditions, may be changed. Participants will then be informed of the new sampling date two days in advance. Subsequent dates rounds resulting from the Schedule will be adjusted by the PT Organizer taking into account the postponement period of the sampling date. The Participant hereby declares that he/she accepts any changes in the round execution dates.

In the case of too few registrations, the PT Organizer may extend the registration period (which may affect the deadlines specified in the Program Schedule for a given round) or cancel proficiency testing for a specific property. Participants will be promptly informed of any changes.

Failure to submit proficiency test results by the Participant, as well as disqualification due to identified collusion, does not exempt the Participant from the obligation to pay according to the scope of the registered participation.

The participant has the right to withdraw from participating in proficiency testing at no cost, which requires submitting a written resignation to the email address: <a href="mailto:badania.bieglosci@barg.pl">badania.bieglosci@barg.pl</a> within 10 days before the planned sample delivery date.
